## DATE RESERVATION Terms and Conditions

- \$1000.00 non refundable deposit to save the date
- Credit Card number on file for final payment
- 50% payment due 90 days prior to event
- Final number guarantee 10 days prior to event
- No personal checks will be accepted unless provided as final payment 2 weeks prior to event
- Last minute cancellations will not be refunded
- Last minute additions, past 10 days prior, billed at 1½ times normal rate
- A drop in numbers from the original proposal of more than 10% will result in an increase of the price by 5% for each 10% drop
- Deposit will be deducted from the final bill
- Any incidentals will be billed and run on the credit card on file
- Any incidentals that run over the amount of deposit will be billed and due immediately upon receipt
- Servers are billed at \$20.00 per hour all staffing that may be required over the amount proposed will be deducted from the deposit
- All events needing service staff are subject to an 18% gratuity and service charge. Events that are dropped off receive a 10% service charge
- All equipment needed to perform the tasks of catering will be supplied by In Good Taste and any necessary rentals due to difficult locations or any unforeseen obstacles will be rented and billed to the contracting client
- Any use fees that are charged to the caterer by a location are billed directly to the client
- Acceptance of deposit by In Good Taste is a binding agreement to perform the tasks outlined with in the proposal and those tasks common to catering
- Any changes to the proposal will occur only with consent of In Good Taste Catering and the contracting client in written form via a revised proposal
- In Good Taste reserves the right to change menu prices to reflect inflation in products that exceeds expected price fluctuation
- In Good Taste must inform the contracting client of any price increase 10 days prior to event

- Providing In Good Taste with a deposit and a signature on this contract implies the acceptance and understanding of the above outlined terms and conditions
  1. I have read the above terms and conditions and by signing below agree to abide by them.
  2. I understand that I am financially responsible for 100% of payment.
  3. I understand that I will suffer penalties for late payment and cancellations.
  4. I agree to pay any attorney fees, collection costs, court fees and any other expenses incurred in collecting any charges under this agreement.
  5. I authorize In Good Taste Catering to charge my credit card for deposits and contracted work under this agreement.
